

Modern Slavery Policy

Touch Projects is committed to ensure there is transparency in our business and in our approach to tackle modern slavery throughout our supply chains.

PART 1: Policy Statement

- i. Slavery is a crime and a violation of fundamental human rights. It takes various forms, such as slavery, servitude, forced and compulsory labour, forced marriage, debt bondage and human trafficking, whether adults or children, all of which have in common the deprivation of a person's liberty by another in order to exploit them for personal or commercial gain. We are committed to acting ethically and with integrity in all our business dealings and relationships and to implementing and enforcing effective systems and controls to ensure modern slavery is not taking place anywhere in our own business or in any of our supply chains.
- ii. We are also committed to ensuring there is transparency in our own business and in our approach to tackling modern slavery throughout our supply chains. We expect the same high standards from all of our contractors, suppliers and other business partners. As part of our contracting processes, we will include specific prohibitions against the use of forced, compulsory or trafficked labour, or anyone held in slavery,

servitude or debt bondage, whether adults or children, and we expect that our suppliers will hold their own suppliers to the same high standards.

- iii. This policy applies to all persons working for Touch Projects or on its behalf in any capacity, including employees at all levels, directors, officers, contractors, graduates, external consultants, third-party representatives and business partners.

PART 2: Responsibility for the Policy

Touch Project's Executive Management Team (EMT) has overall responsibility for ensuring this policy complies with our legal and ethical obligations, and that all those under our control comply with it.

This policy cannot be amended without approval of the EMT.

The EMT has primary responsibility for implementing this policy, monitoring its use and effectiveness and dealing with any queries about it. The EMT's responsibilities extend to overseeing the:

- i. monitoring and consulting of internal controls and

procedures to identify risks of modern slavery practices in our operations;

- ii. monitoring and consulting with our suppliers, contractors and business partners to identify risks of modern slavery practices in our supply chains;
- iii. development of measures to assess and address any risks of modern slavery practices, including through due diligence in our contractual relations;
- iv. monitoring of the effectiveness of those measures, and
- v. development of appropriate materials for our employees to comply with this policy.

Senior management within Touch Projects is responsible for ensuring those reporting to them understand and comply with this policy and are given adequate information regarding the issue of modern slavery in supply chains, including any areas of our business and supply chains which are identified as at risk of modern slavery practices.

You are invited to comment on this policy and suggest ways in which it might be improved. Comments, suggestions and queries are encouraged and should be addressed to the EMT.

PART 3: Compliance with the Policy

The principles of this policy must be complied with or incorporated into policies within the business units or subsidiaries within Touch Projects.

The prevention, detection and reporting of modern slavery in any part of our business or supply chains is the responsibility of all those working for us or under our control. You are required to avoid any activity that might lead to, or suggest, a breach of this policy.

You should notify the EMT or your manager as soon as possible if you believe or suspect that a conflict with this policy has occurred or may occur in the future.

You are encouraged to raise concerns about any issue or suspicion of modern slavery in any parts of our business or supply chains of any supplier tier at the earliest possible stage.

If you believe or suspect a breach of this policy has occurred or that it may occur, you should notify the EMT, your manager as soon as possible.

If you are unsure about whether a particular act, the treatment of workers more generally or their working conditions within any tier of our supply chains constitutes any of the various forms of modern slavery, raise it with your manager.

We aim to encourage openness and will support anyone who raises genuine concerns in good faith under this policy, even if they turn out to be mistaken. We are committed to ensuring no one suffers any detrimental treatment as a result of reporting in good faith their suspicion that modern slavery in whatever form is or may be taking place in any part of our own business or in any of our supply chains. Detrimental treatment includes dismissal, disciplinary action, threats or other unfavourable treatment connected with raising a concern. If you believe that you have suffered any such treatment, you should inform your manager or a member of the EMT immediately.

PART 4: Communication awareness of this Policy

We aim to encourage openness and will support anyone who raises genuine concerns in good faith under this policy, even if they turn out to be mistaken.

We are committed to ensuring no one suffers any detrimental treatment as a result of reporting in good faith their suspicion that modern slavery in whatever form is or may be taking place in any part of our own business or in any of our supply chains.

Detrimental treatment includes dismissal, disciplinary action, threats or other unfavourable treatment

connected with raising a concern. If you believe that you have suffered any such treatment, you should inform your manager or a member of the EMT immediately.

PART 5: Breaches of this Policy

Any employee who breaches this policy may face disciplinary action and any serious breach of this policy may result in dismissal for misconduct or gross misconduct.

We may terminate our relationship with other individuals and organisations working on our behalf if they breach this policy.
